Summit County Library's Library of Things Use Agreement

Borrowing guidelines:

- Library of Things equipment and kits are available for checkout for patrons 18 and up.
- Users must have a current Summit County Library card and have no outstanding fees to borrow equipment or kits. Guest and Reciprocal card patrons may borrow equipment and kits.
- Check out for Library of Things is 2 weeks with no renewals. Except for the Quandary Parking Pass and the Colorado State parks passes which are 1 week with no renewals.
- Items must be returned to the Main Library in Frisco Circulation desk. (not in the book drop)
- Cardholders are responsible for all materials checked out on their card. In the event that an item is lost, damaged or not returned, charges will be applied to the cardholder's card for replacement value.
- In the event that a singular item is lost or damaged from the kit (say a book) the Collection Manager can determine the value of that single item for replacement charges.
- Until the kit is returned, or fees are paid, the Patron's library card privileges are revoked, and their card is blocked from use.

To borrow a Library of Things kit or item, I agree to and understand the following:

- I will present a photo ID and my own valid Summit County Public Library card in good standing.
- If the kit is lost or stolen while checked out to me, I understand that I am responsible for the replacement cost at the time of the loss.
- I will visually inspect the kit before return, itemizing each item on the check list and making sure the item is clean and in the same condition as it was when I borrowed it. Otherwise, I will bring any damages to the attention of the staff person checking it out to me. I will pay the incurred costs for the Summit County Library to replace or repair the kit.
- I will return the kit to a staff member (not in the book drop or left on counter) by the time it is due. I understand that a library staff member will inspect the kit and assess that it is in the same condition as when I borrowed it. I will allow time before I need to leave so that this inspection will not be rushed.
- I acknowledge that failure to return the kit on time may result in revocation of borrowing privileges. I will pay the cost to replace kit if I fail to return it.
- I agree to release, waive, discharge and covenant not to sue the County for any injuries or any damages that may arise from the use of any items from the Library of Things collection. I further agree to assume all risks associated with the use of these items. I agree to indemnify, defend, and hold harmless the County, both collectively and individually, in addition to its respective agents, elected officials, officers, directors, owners, contractors, volunteers, and other employees (collectively the "Released Parties"), from any and all liability actions, causes of action, debts, claims, and demands of

every kind and nature whatsoever which may arise during the course or as a result of the use of items from the Library of things collection.
