OLD BUSINESS

Strategic (SMART) Library Board Goals for 2023 (Theresa)

- Haley put together a document but no one has contributed ideas to the document.
- One of the Feb training suggestions was to create a list of goals for 2023.
- The Board brainstormed the beginning of a list of goals for 2023:
 - 1. Expanding search techniques to attract more diversity to the library board (Latino and other immigrant populations, men, seniors, etc.)

2. Quarterly board trainings

3. Create community connections in an effort to better reach and serve local populations that don't frequent the library.

One Card Update (Theresa)

- The school board approved the One Card program, which would allow students to use their school ID at Summit County Libraries and make the library and its resources more accessible to all students.
